The Reserve Bank of India (RBI) and the Securities and Exchange Board of India (SEBI) regulate forex trading in India.

In India, the Securities and Exchange Board of India (SEBI) is the primary regulatory body that oversees and controls the stock market, ensuring its efficient and transparent operation and protecting investor interests.

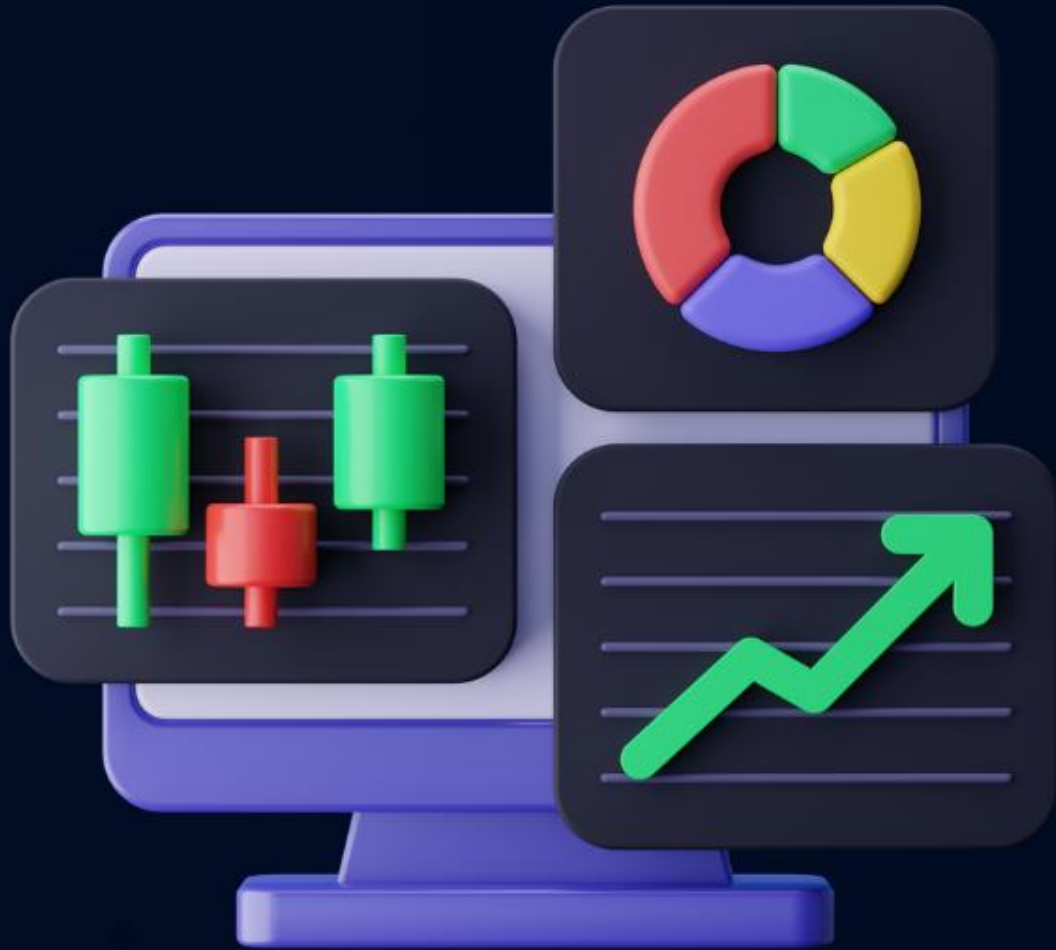
